

Meadowmere LARP, LLC Waiver of Liability and Hold Harmless Agreement

1. I, in consideration for myself _____, hereby release, waive and discharge all people involved with or associated with Meadowmere LARP, LLC (hereinafter referred to as RELEASEES), from any and all liability, claims, demands, actions, and causes of action whatsoever arising out of or related to any loss, damage, or injury that may be sustained by myself or to any property in the possession of myself, while participating in Meadowmere LARP, LLC events or functions, or while in, on, upon, or traveling to or from any program activity where Meadowmere LARP, LLC events or functions are being conducted.
2. I am fully aware of the risks and hazards connected with allowing myself to participate in this activity, including the risk of physical injury or disability as the result of such injury, and I hereby allow myself to voluntarily participate in said activity. I voluntarily assume full responsibility of any risk of loss, property damage, or personal injury that may be sustained by myself, or any loss or damage to property in the possession of myself, as a result of being engaged in such activity.
3. I further agree to indemnify and hold harmless the Releasees from any loss, liability, damage, or costs that may incur due to my participation in said activity.
4. It is my express intent that this Waiver of Liability and Hold Harmless Agreement shall bind the members of my family and spouse (if any), if I am alive, and my heirs, assigns, and personal representatives, if I am not alive, and shall be deemed a release, waiver, and discharge above named Releasees. I hereby further agree that this Waiver of Liability and Hold Harmless Agreement shall be construed in accordance with the state laws where the event or function is being held.
5. I understand the Releasees will not be held responsible for any medical costs associated with an injury that I, myself may sustain.

I further agree to become familiar with the rules and regulations for my conduct and agree that I will not violate said rules or any directive or instruction made by the persons in charge of said program and that I will further assume the complete risk of any activity done in violation of said rule, directive, or instruction.
7. I also understand that I am urged to obtain adequate health and accident insurance to cover any personal injury to myself which may be sustained during the program or transportation to or from said program and activities. 8. I agree to abide by the supervision of the Game Masters (hereinafter referred to as GMs) and will follow their judgments regarding unsafe behavior and use of Meadowmere LARP property or equipment. I acknowledge that the GMs have full authority at Meadowmere LARP, LLC events and that they may prohibit me from participating in an event involving combat or game content if I ignore their warnings on my own behavior and actions. I understand that I have the authority to submit a complaint in writing, if I feel that any aspect of my health is unsafe during club events. 9. I hereby grant Meadowmere LARP, LLC, their legal representatives and assigns (including any agency, client, or publication), irrevocable permission to publish photographs of me taken at any Meadowmere LARP, LLC event or function. These images may be published in any manner, including advertising, periodicals, greeting cards and calendars, whether in print, on social media or on the internet. Furthermore, I will hold harmless Meadowmere LARP, LLC, their representatives and assigns, from any liability by virtue of any blurring, distortion or alteration that may occur in producing the finished product, unless it can be proven that such blurring, distortion or alteration was done with malicious intent toward me. I affirm that I am more than 18 years of age and competent to sign this contract. I have read this release and fully understand its contents.
